The Arbitration Act 1996 is an Act of Parliament which regulates arbitration proceedings within the jurisdiction of England and Wales and Northern Ireland.. The 1996 Act only applies to parts of the United Kingdom. In Scotland the rules governing arbitrations are found in schedule 7 of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 and are based upon the UNCITRAL Model Law.
