To avoid a 2014 tax underpayment penalty, most taxpayers are required to pay either 90% of their 2014 tax or 100% of their 2013 tax, whichever is less. However, if your 2013 AGI was more than \$150,000 (\$75,000 if your 2013 filing status was married filing separately), you must pay 90% of your 2014 tax or 110% of your 2013 tax.
