A sheriff court (Scottish Gaelic : cùirt an t-siorraim) is the principal local civil and criminal court in Scotland, with exclusive jurisdiction over all civil cases with a monetary value up to £ 100,000, and with the jurisdiction to hear any criminal case

Commercial disputes with a value of over GBP100,000 can be heard in the Court of Session.
