A parenting coordinator has completed a minimum of 40 hours in family mediation training, generally 20 hours of parenting coordination training and has experience working with divorce and families. The number of PC training requirements are determined by each state as part of their local rules or state statues.

The therapist recommended that the parents and the child attend a four-day "divorce camp" for high-conflict cases. The camp is in California and costs \$9,000 per week. The PC agreed with the therapist and instructed the parties to attend the camp but the parties did not go.
